Introductions

Presentation: A toolkit for improving media coverage of the refugee crisis

Presenter: Alia Dharssi: Journalist and researcher, The Discourse.

Introduction: Alia Dharssi is a journalist and researcher who has written widely about immigrant, refugees, human rights and global development for Canadian and international media, including the Guardian, the National Post, the Thomson Reuters Foundation and Al Jazeera. In 2016, she wrote a six-part series on Canadian immigration policy that was published in Postmedia newspapers across Canada. This year, as Sustainable Development Reporter at The Discourse, she co-produced a toolkit for journalists and refugees to help improve coverage of the refugee crisis. It includes information to help refugees preparing to share their perspectives with the media, as well as best practices for journalists who report on refugee issues based on input from over 30 newcomers, settlement workers and academics.

Alia's presentation aims to share a project completed at <u>The Discourse</u> which focuses on slow journalism – producing stories of interest to the public.

The Discourse is engaged with refugee issues because it is said that Canada makes a big contribution to world in terms of refugee protection so it's a story of interest.

At the Discourse they started to engage with refugees and hear that they were only interviewed at times of crisis — so the Discourse started working with Options and PIRS to invite refugees to discuss; including refugees from all over the world.

It was obvious that they needed to publish more diverse stories – and from more countries, not just Syria, not just govt/private but also claimants. Likewise, it is important to look beyond crisis to solutions and resettlement challenges for refugees.

The refugees and settlement agencies they spoke to had a lot of questions about how journalism works – and they wanted to follow up stories and an ongoing engagement.

There were all sorts of new challenges in terms of doing journalism with vulnerable groups, so the Discourse worked to produce a **Toolkit** which is available online.

The toolkit contains two sections:

a) Best practices for journalists

b) Tips for Refugees

The following are 10 tips for Refugees:

- 1. Ask the journalist questions before agreeing to an interview
- 2. Be prepared to have your image and words recorded
- 3. Ask to see journalist's principles and practices and ask what kind of story they are working on.
- 4. Look at what that media outlet has covered in past to understand their leanings
- 5. Tell reporter beforehand if they don't want to be identified (to protect themselves and family back home) and ask what the reporter will do to protect their identity.
- 6. Be prepared for hate mail etc. as story can go around the world.
- 7. Be prepared to verify your story back it up with documentation.

- 8. Understand difference between 'on the record' 'background', 'off the record'
- 9. If you want to share your story try and find a media outlet or reporter who shares your viewpoint
- 10. Be prepared that talking about your story may be triggering.

Questions and Answers

Carlo: Suggested that claimants have a counselor in support because talking about their life can be triggering and the reporters sometimes objectify claimants as 'illegals' or other stereotype.

Answer: Reporters don't have resources for this unfortunately. Before at the DISCOURSE a reporter with First Nations women did, but many wouldn't have these resources. In the Best Practices section for journalists we recommended that reporters suggest this to clients or their agencies. It's best to discuss this with the claimants so they can refuse if necessary.

Discourse encourages reporters to call claimants by their profession or another positive identifier.

Mariana: need to keep **connectors** (workers who make referrals to journalists) accountable. So that they act responsibly when making a referral. Don't use a claimant if the experience is not going to be positive for the individual.

Claudia: (MSDPR) Referred participants to a publication titled 'Inside Stories' – focussed on long term settlement – in different Vancouver neighborhoods – and asked the question: Where do you feel you belong? It was very emotional and triggering but the reporter made connections earlier and used pictures not video – not necessarily of the person but objects or places connected to the story.

Question: Louisa (Covenant House) As a settlement worker she is concerned about how to speak to their donors about Covenant House clients. So they are very grateful for the toolkit.

Franklin (Purpose) How would claimants know about reporter's best practices? It must be our responsibility as settlement agencies to take this on.

Answer: Agreed, we have also talked to IRCC, and furthermore we want to translate materials to make them more accessible.

Question: Loren (Kinbrace): You talked about Principles & Practices – journalism seems to be predicated on provocative soundbites. Do you have any comments on how we can break that soundbite process? How to navigate it without getting in the way?

Answer: yes, there is a lot of polarization currently, and social media makes it worse. You don't have any control once you've shared your story as journalists will edit as they care to. That's why its very important to know what kind of outlet your talking to and how they treat sensitive material. Is it someone who will make a deeper dive or just glossing over the subject? CBC and Globe & Mail good, though US media creeps over social media

make the atmosphere more polarized.

Question: Huguette (La Boussole / UCI) – she has been approached several times to find refugees to speak. She's always concerned about confidentiality so never connected anyone. She knows there's a need for public education, but they have had bad experiences of people being picked up after speaking to reporters. How can we trust the media?

Answer: it's very difficult – some journalists are more worried about deadlines than ethics. You must discuss with reporter upfront about security concerns – then if you feel comfortable you can make an introduction.

Why ask for documentation?

Answer: To verify the story – some information that's lodged with the government can be checked (e.g. country backgrounds) because it's public. Even social media may ask for verification.

Mariana (VAST) IMPORTANT! - extra care should be taken when interviewing a claimant in the pre-determination phase prior to their hearing/decision.

Answer: It's very important for us to explain these factors to journalists.

Carl@ (Qmunity): Reliable sources may not include social media – and can do damage to claimant's case.

We should develop education for claimants because they don't know when to say no. But they need support.

Mariana – agreed. It's not always because claimants don't know the risks, but also because they may feel pressured to speak – out of gratefulness etc.

Question: Katherine (MOSAIC) What about self-publication style of stories from agencies – are there any tips for agencies themselves?

Answer: be careful to manage expectations about your following – may not reach a big audience – ask yourself if self-publishing is the best way or using a different platform.

Alexandra (MOSAIC) – there exists a power imbalance – we need to be very aware of this when we are encouraging the client, and consent piece. Can we see the story before it's published?

Answer: You can't see whole story, but you can ask about it's direction or check on security of your identity etc.

Agreed that the power imbalance is SO important – we must not push refugees.

Why can't see story before?

Answer: Because reporters must be free and have their own control so that they are not seen as biased. They have many time constraints too.

Mariana: can you add interpreters to best practices rules?

Huguette (La Boussole/UCI): Interpreters may add to the story themselves – so this is a very important question about how to involve interpreters.

Answer: we haven't worked on this much – but in our workshops we excluded people who couldn't speak English in order to not run into this problem. Connectors must make that clear to the interpreters.

Mariana thanked Alia for a very interesting presentation.

Request for support from members to the MAP Submission to the Federal Standing Committee on Immigration and Citizenship. – Jenny, MAP Coordinator

Jenny explained that following a meeting with Hon Jenny Kwan, NDP critic on Immigration and member of the Standing Committee on Immigration and Citizenship, it was suggested that MAP make a submission especially around the issue of housing for claimants and also the request to be consulted as a group in Western Canada. To date there have been submissions from VAST, Collingwood Neighborhood House and ISSofBC from the west.

The Standing Committee is accepting submissions up until November 30th. Jenny Kwan recommended MAP collect supporting submissions too, all of which must be submitted to the Standing Committee via an online portal, and a copy should be sent to Jenny Kwan, so she can support our case.

Jenny distributed the letter from Hon. Jenny Kwan with details of the Standing Committee and submission procedure, as well as a template for agencies to follow if they wished to support MAP's submission. Jenny collected names of agencies and individuals interested She will email each one with the same documents and more information.

Break

Quantitative and qualitative update on Refugee Claimants in the Lower Mainland Bahar Taheri, BC Refugee Hub

Mariana communicated that Bahar was not able to attend MAP, here is her update:

- 1) the Nov 1st webinar video has been posted on the hub along with the PowerPoint decks and resources

Regional input for Canadian Council for Refugees Fall consultation Nov. 26 – 28

Canadian Council for Refugees is a national non-profit umbrella group outside of the government and representing refugee interests. Many MAP agencies are members. CCR is very active in presenting issues to govt.

MAP Housing Working Group Report and Discussion

Presenters: Loren Balisky & James Grunau (HWG co-chairs)

Background:

The HWG is working on **Towards a Housing Solution for Refugee Claimants in BC's Lower Mainland.**

The Province has funded us in response to the Forum last May We are about halfway through time allotted by Province (Sept '18 – March -19) and we have built a solid foundation.

Updates on the project:

1. Loren:

- We are starting our **asset mapping research** regarding claimants: this is new to Canada, never done before.
- HWG wants to put all this information in an accessible place doing a scoping exercise right now with the winners of the RFP as the Asset Mapping
 Committee has a recommendation as to who should take on the research.
- You will all be key participants to that research thanks!

2. James:

- focussing on immediate housing solutions:
- **Alice Sundberg** has been hired to determine what is happening right now with housing referrals for claimants she has met with MAP members around immediate pathway and longer-term pathway to housing.

The challenge is with the closing of Inland Refugee Society we know there's a gap – how can we address it?

We need to look for another funding source and champion to continue the work.

3. HWG is also looking at a long-term solution in terms of a welcoming center for

RC. The idea is a 'landing space' with short term shelter (2-4 weeks)

- modular housing setup
- supported pathways to permanent housing in welcoming communities. We need to build supporting communities for RC's to move out to more transitional housing.

Loren – introduced a **discussion exercise** to gather more opinions from MAP Participants discussed in groups of 3 what were their hopes for a Welcome Center for RC's. The following **ideas** were gathered:

- A Reception center with good flow out
- RC's be involved in design
- Thinking about ISS Welcome center it's best to duplicate it for RC's
- Sometimes when the plan gets too big it gets complicated:

Who would be the leader?

Funding source?

Modular housing concept worth following in different cities

 Create an APP to login and learn about whole process including how to find employment and legal pathway as well as housing

- Integrating into communities important educating local communities to accept claimants as equals.
- Consider approaching Bitco other partners
- Provide 1 hub and transportation to appointments
- The Center should be seen as part of a pathway or solution.
- Must be a safe place for LGBTQ community and survivors of violence
- Must have universal bathrooms
- IRB to relocate their offices to affordable smaller centers
- IFH-accepting clinic, center with language support, play, art, intentional humancentered

The Triangle represents mountains in BC landscape Interlocking triangles represent community and partnership Each triangle flows back and forth into each other showcasing interconnectivity and transformation

Comments:

Mariana (VAST) not sure about the word 'for' in the tagline.

The thinking was explained by Richard as:

Although a little word, for is about helping refugee claimants get their voices heard, it's about action too – MAP is working to make changes and keep refugee claimants in people's hearts and minds. Although we're not an advocacy group, for shows that we are united in making life better for refugee claimants. In this case 'for' is not to say that MAP directly works for RC's but stands 'for' them.

WEBSITE

The IWG is also updating the website and Richard showed the model (not yet public) that has been thought through.

The front page will feature stories of member agencies, current MAP projects, claimant

stories.

It has the standard sections: About, News, Issues, Ways to Help, Resources, Contact, and a password protected Member area.

COMMENTS:

Flip the image on the homepage

Richard explained that because the image has to be cellphone friendly it is a responsive design and will adjust to the medium used.

- Put a disclaimer on MAP doesn't do advice, direct sponsorship etc.
- Change 'What is a refugee?' to 'Who is a Refugee?'
- Will the website be in French? Possibly though there are many other languages we would need to consider too. Perhaps down the line.
- A suggestion was made to consider cultural sensitivity training

Website will portray MAP as a connector – will be clear on what we do and don't do; as well as MAP's long-term plans.

We will begin slowly and can add as we go.

OTHER IWG PROJECTS

We are also working on a PUBLIC EDUCATION CAMPAIGN and plan to launch an event in early spring to counter the negative publicity claimants are receiving.

Our long-term goal is to secure more funding and roll out a strategy around public education.
