- Alexandra provided welcome and introduction to FV MAP Meeting, and acknowledged that the FV MAP meeting was held on the unceded territory of the Sto:lo First Nation.
- Alexandra expressed that ACS has become Archway Community Services.
- Attendees introduced themselves.
- May 14, 2019 meeting minutes were reviewed and approved.

Presentation: Canadian Red Cross – Supporting Refugee Claimants

Mandana Salimian – Emergency Management Coordinator, Canadian Red Cross

Introduction to Red Cross/Red Crescent

- Overview of fundamental principles held by organisation
- Founded in 1909; present in 190 countries today
- Mission: improve the lives of vulnerable people by mobilizing the power of humanity in Canada and around the world
- 3 main areas in Canada: Disasters & Emergencies; Health & Wellness; Prevention & Safety
 - Refugee claimant program falls under Disasters & Emergencies (in the Emergency Management program)

First Contact Program: November 2008 – October 2017

- 24-hour multilingual Info + Referral Line for RCs or those wishing to make claim in BC
- Emergency accommodation/transportation/food to claimants for first 72 hours from start of RC process
- Entirely staffed by volunteers + only 1 staff member

Reason for transition from First Contact to BC211

- Expertise → Highly trained; interpretation; etc.
- Resources → Capacity; database; data tracking; etc.
- Reducing duplication

BC211 – Info and Referrals

- Info Kit available in 5 languages → Provided to RCs at ports of entry, IRCC office, settlement agencies
- Call 2-1-1
 - Phone agent conducts brief needs + vulnerability assessment
 - Provides I&R:
 - SOS
 - Legal Aid
 - MOSAIC
 - Others as needed
 - o If caller presents urgent needs → Dispatches call to a Red Cross on-call Duty Officer



Red Cross:

- BC211 triages calls and Red Cross continues to support vulnerable RCs as referred by BC211
- Red Cross continues to provide vulnerable families up to 72-hour assistance for commercial lodging, clothing, food and transportation
 - Focus on commercial lodging
- Question (Sukaina): What if RCs still call Red Cross directly?
 - o First Contact phone number is no longer connected.
 - o If RC calls provincial 1-800 # for Red Cross, it will be answered by Duty Agent on call
 - Clients and client serving agencies are encouraged to go through BC211 to most effectively funnel calls.
- Question (Alexandra): The commercial lodging available at hotels through Red Cross is a huge asset. Is that available to RCs in the Fraser Valley?
 - Red Cross works with travel agencies nationally
 - o If someone is in FV, the travel agency will find commercial lodging with availability
- Question (Sukaina): How long can they stay in the hotel?
 - o 72-hours is the official mandate
 - However, there is some flexibility when it comes to RCs
- Question (Donna): Does Red Cross help family find housing while they're in hotel paid by Red Cross?
 - o No → Role of settlement agencies
 - o Red cross is dedicated to *emergency* support
- Question (Sherman): Does Red Cross have geographic settlement data?
 - No, only first point of contact data is collected.

2018-2019 Red Cross Refugee Claimant stats in BC (until June):

- Red Cross has served 315 refugee claimants (financial support) → 80 family units
 - Average family size = 4
- 30 countries of origin
 - o Middle East (Afghanistan, Iran, Iraq, Pakistan, Egypt)
 - o Recent increase of South/Central America
- Almost 95% of services provided = Commercial lodging
 - 313 provided with lodging
- Recent trend: Refugee claimant families moving to BC from Quebec

Question (Katherine): Could you clarify vulnerability criteria?

- As long as you are a family and in need, BC211 will refer to Red Cross
- Single male and female → *Not referred* (until presenting more complex situation, e.g. domestic violence, mental wellbeing issues, physical challenges ext.)

- Lisa will send a list to Alexandra of services/conversation circles/etc. that SWIS knows about in Langley to share through FV MAP mailing list.
- Stats from BC Refugee Hub → reflect 0 RCs in Langley but this is not accurate
 - o Alexandra comment: MAP FV priority is to contribute accurate, comprehensive data

The resources available will be divided based upon municipality, drawing from feedback from today's exercise, in preparation for this autumn.

- LINC closed for summer

- Summer Conversation Circles: Monday, Wednesday evenings; and Tuesday during the day
- Regular programming will resume September 16

Dardane (ACS): Around 10 ACS staff will be at Mill Lake WRD event at June 22

Donna (ACS): June 25th information session for refugee claimants \rightarrow Will be introducing counselling services, presented as "wellness opportunities, yoga ext." The counselor will be at info session to introduce herself

- Free 2-day per week, 5-week Summer camps → literacy summer camps for middle school and high school (open to all status)
 - o 12 registered already; max 15



Kanta (SD34): large # of children of temp foreign workers → raising awareness at teacher level of different needs (RCs vs. TFW vs. etc)

Approach: serve them all (regardless of funding differentiation)

Alexandra (MOSAIC): will offer FirstAid/Foodsafe certificates for refugee claimants Vancouver − July, Surrey − August. → Will circulate registration info. If this is a need in your community please advise.

- Planning to offer summer programming for children/youth
- Stats = 68 new clients served under MOSAIC Stream B funding last month
