PRESENTATION: Medical Services Plan (MSP) of BC

Presenters: Glady Chang and Svitlana Hupalo

Eligibility, Compliance & Enforcement Unit, Audit and Investigations Branch, Ministry of Health

Glady Chang is the Senior Eligibility Investigator and has been with the unit for 5 year. Prior to joining the Ministry of Health, she was with the Ministry of Finance for over 10 years.

Svitlana Hupalo is an Eligibility Investigator who has been with Eligibility, Compliance and Enforcement Unit (ECEU) for a year now. Before joining the Ministry of Health, she worked at the Ministry of Social Development and Poverty Reduction.

QUESTIONS & ANSWERS

Question: Refugee Claimant children do not need a study permit to study in Canada, sometimes they are given them, but they are not needed as they are covered under their parents. Why are some children whose parents submit the study permit not knowing they don't need to, charged international fees, when all other refugee claimant children are not?

Response: If a child was born in Canada, so a Canadian citizen he/she would be eligible for date of birth coverage. But if a child wasn't born in the country, or was born to parents without legal status, the legislation states that the parents and child would not be eligible for the same coverage.

Such children receive coverage after a wait period of 3 months. For example: if a child was born as of today's date on May 28, the child will be considered a new resident and required to serve the remainder of the month of May and

two following months June and July. So in this case the child coverage will be effective as of August 1st. The treatment will be the same as a new resident or returning resident in this case.

Question/comment: We've had some families charged MSP premiums when they should not be, refugee claimant children whose parents have a work permit do not need a study permit.

Some parents have submitted study permits thinking they should - and then have been charged the international student premiums. But all other families who didn't submit the study permits were not charged.

Response: Jenny has the answer sheet from the Health Insurance BC to be shared with members.

In general Health Insurance BC is the administrator for the medical services plan program. For questions, they have a specific email address: refugee@hibc.gov.bc.ca

Question: Is there a fee for the double card (Drivers' License & Care Card)?

Response: Service cards (Care Cards) are free. If you want the combined card then you pay the Driver's License portion, but the Service cards are free.

Questions: Why do children born to refugee claimants in Canada have to complete the wait period and be subject to charges? They are considered Canadian citizens and their mother has status in Canada is covered under IFHP.

Response: The legislation states that only children of Canadian citizens, or permanent are not required to serve a wait period. If they are new residents to BC, or if they are returning residents to BC, they are required to serve the wait period.

Question: How can a child be eligible for the Healthy Kids program?

Response: Healthy Kids program is available to beneficiaries who have been approved eligible for supplementary health benefits. The family members need to be enrolled in MSP and have medical coverage. The family's net income must be less than \$42,000 a year, then they can apply for supplementary health benefits. There is a separate application which needs to be sent to Health Insurance BC and if found eligible for supplementary benefits, the Healthy Kids program automatically checks in, no additional application needed.

Question(s) What is covered under the interim federal health program?

What is the difference between the interim federal health program and MSP?

How long are refugee claimants covered under IFHP?

Response: MSP can't speak for the federal government (IFHP is a federal program). When refugee claimants do not have legal status in Canada, they are not eligible for the medical service coverage. The federal government provides a program that looks after their medical needs called IFHP.

Question: What is the best way to apply for MSP for Refugee Claimants?

Response: see contact information at the end of MSP Q&A

Question: Is there any increase in dental coverage under MSP?

Response: No. Emergency dental services for the relief of pain are provided to all recipients of income assistance, disability assistance, and hardship assistance. Basic dental services are also provided to children whose parents are in receipt of BC Employment Income Assistance.

PRESENTATION: CBSA Update: Use of ATD's and the IHC during COVID-19 Pandemic

Presenter 1: Jolene Grant - Community Liaison Officer: Intelligence and Enforcement Branch / Pacific Region

Her responsibility is to work in **Case Management Supervision Program** and with service providers: **John Howard Society and Belkin House**.

Both high and low risk individuals are included because of their specific needs.

ATD's have been fully utilized since June 2018 – and in different ways to fulfill the CBSA mandate:

- In person reporting
- Voice reporting
- Cash bonds and deposits
- Rules for release
- Detention in John Howard Society facilities: Vancouver, Victoria and Thompson/Okanagan
 Prior to COVID-19 there were 353 individuals in the voice reporting program.

Once COVID-19 began CBSA reviewed the use of their arrest and detention program so that they can report:

- Since March there has been a significant increase in the use of ATD's to avoid arresting.
- Officers are using more terms and conditions, as well as placing individuals on in-person or phone reporting.
- Most of the in-person reporting individuals have moved over to phone reporting: CBSA is undergoing a review project to move all their in-person reporting over to phone reporting to CBSA reception, which avoids having to come into the office. Hopefully they can all transfer to the automated phone reporting system on a permanent basis which avoids individuals taking time off work or travelling far to report. There are quite a few who will transfer to this program and still fulfill their terms and requirements.
- Jolene has also been reviewing with Manager of the Hearing Unit all those currently in custody cases, to see who can be moved to the ATD program want to use these tools where possible. These individuals would not necessarily be candidates for ATD but under the current circumstances it is more appropriate.
 - They have also recommended the release of a number of detainees to ATD program, and will continue to review on a monthly basis and just before detainees' reviews.

Question: Would the CBSA allow in-person reporting at Service Canada offices or at a John Howard location for those living in the Fraser Valley far from Vancouver?

Response: Would not allow reporting to Service Canada – they would rather be put on voice reporting automated system. They just need access to cell service – so anywhere in BC or Yukon.

Can't check in at John Howard for immigration purposes, but they could for CCMS program. They do regularly check in this way and it has helped during times when the automated telephone system has been down, or individual couldn't get in to a CBSA office.

Question: when will Chatr service be re-enrolled as a phone provider to voice reporting?

Response: this is being re-negotiated by the ATD team in Ottawa with Chatr, but this service will not be used for location-based services.

Presentation 2: Sharon Sandhu: Detention Manager at new IHC in Surrey.

Sharon has been at the new IHC since February.

Facility opened with its first detainee on March 9.

Shortly after the COVID pandemic struck and opening the IHC was happening at the same time.

Fortunate to have health services on site: medical director and contract manager for health and they are providing information to help with protocols for the staff and guards. Taken a lot of precautions:

- all visitation to facility closed – other than professional visits: counsellors, interpreters, NGO's who can use non-contact visitation rooms.

Plenty of PPE that is being used.

They are regularly reviewing who can be released to ATD program as Jolene described.

Chantal Boulet: Manager Detention Operations, Surrey IHC added:

4 detainees currently:

2 who have been there for 4 weeks - healthy

2 new detainees just arrived so they are residing separately from the other 2 under COVID protocol (2 are in refugee stream and the other 2 are not)

They have procedures in place for how to respond if a detainee does develop COVID symptoms.

They wear full PPE in common areas like recreation

Have a quarantine area if anyone shows signs of illness.

Investigation team has been detaining and releasing on same day where ID is not a questions – in order to keep detention very low.

Have a lot of guards and few detainees but keeping everyone healthy through protocols for example with cleaning and food companies.

Question: are the two folks in the IHC refugee claimants?

Response: 2 were previously in the refugee stream, and 2 are not.

Mariana thanked everyone – MAP members can send in questions to pass on to CBSA.

Report on Housing Referral Project – lead agency MOSAIC Alexandra Dawley

COVID-19 has delayed the project a bit.

Alexandra provided a brief background on the project that hopes to build on an existing referral system working closely with MAP.

Currently in the first phase:

- Already created an Advisory Committee first meeting Monday June 8 at 1:30pm
- Involved in a scoping exercise of what housing inventory and referral systems currently exist

Needed to change some of the processes because of the pandemic but looking forward to more progress.

Question: Has a project lead been hired yet?

Response: We identified a consultant and have been working with the province for the past couple of months to finalize details.

We did interview some strong candidates but in the end it went to a consultancy.
