The meeting was called to order by MAP Co-Chair: Mariana Martinez Vieyra (VAST)

- Mariana acknowledged she was speaking from the territories of the Coast Salish Nations of Musqueam, Tsleil-Waututh and Squamish nations, and that those attending were located on the ancestral territories of many other First Nations.
- Mariana also stressed that MAP members have a role in opposing social injustice, systemic racism and oppression as it exists in Canada.
- Thanks were expressed to the Ministry of Jobs, Economic Development and Competitiveness for the funding that supports MAP.
- Welcome: there were 80 participants, Mariana recognized the 36 MAP member agencies who were present – please see updated list attached.
- Mariana reviewed the agenda and it was approved.

PRESENTATION: Lobat Sadrehashemi, Refugee Lawyer, Immigration & Refugee Legal Clinic Current legal concerns for Canada's refugee claimants and an overview of the resources provided by the new Immigrant & Refugee Legal Clinic

Introduction: Lobat Sadrehashemi is a refugee and immigration lawyer practicing in Vancouver. She is senior counsel and clinic lead of the Immigration and Refugee Legal Clinic. Lobat regularly acts for clients at the Federal Court and the Immigration and Refugee Board. She has argued at all levels of court, including the Supreme Court of Canada. Lobat's practice includes refugee hearings, judicial reviews, motions for stay of removal, immigration and refugee appeals, detention reviews, admissibility hearings and other immigration applications.

Lobat is Past President of the Canadian Association of Refugee Lawyers (CARL) and on the legal committee for West Coast LEAF. She has also served as Chair of the Canadian Bar Association's Refugee Lawyers Group in Vancouver.

- Lobat was trained as a law student by working in legal clinics in Ontario and always wanted there to be one in Vancouver. In earlier years in BC, legal clinics used to exist, but many were closed in 2002 and since then private lawyers have been representing refugees with scarce legal aid support. Challenging cases (e.g. those in detention, cases with little lead time or special vulnerabilities) could end up in the hands of inexperienced counsel, because it was difficult to find experienced counsel to take on all of these cases.
- In 2019 a report was written recommending reconstituting the legal clinic system in BC, and a refugee clinic was recommended to ensure that a competent lawyer takes on those complicated, sensitive and urgent cases.
- Government funded the rebuilding of legal clinics housed across the province in different agencies and provides a staff lawyer and legal assistant. There are 7 clinics:
 - 4 poverty law clinics
 - 3 specialized clinics: disability rights, tenancy, & immigration/refugee legal clinic.
- Refugee Legal clinic opened in April 2020 (although the pandemic means they work at distance)
 - 2 lawyers: Lobat and Tien Tran and assistant Jinhee Lee.
 - Housed at ISSofBC but independent the clinic decides the cases they take and advocacy strategies – separation to ensure client confidentiality
 - Not able to fill all the glaring gaps but hope to fill some gaps some of the time –
 - See slides for <u>vision and guiding values</u>
- Categories of work:

Legal advice & Information: summary advice appointment – not an offer to take on case. For low income clients they can contact clinic for an appointment to clarify their options, including in more complex cases on how to approach legal aid about the legal assistance they need. Might be referred to legal aid or different agencies, or possibly be taken on as a case of the clinic.

*Representation at Courts and Tribunals: can fully represent legal cases – see later notes.

Systemic Litigation – cases that might have a broad impact – part of advocating for policy change and law reform

Mentorship & Education – important role in education – and plan to offer mentorship for junior lawyers and law students.

*More detail about Representation:

don't want to have a huge waitlist

<u>Don't have strict limits on what kinds of cases to take (if meet financial eligibility and is an immigration/refugee issue that requires legal submissions) but must prioritize carefully.</u>

Consider these factors in deciding which cases they take on:

- can't find appropriate lawyer
- case is legally complex
- sensitive client care issues or detained person
- requires immediate action
- capacity of the clinic.

No fees for the legal services as clients must not be able to afford a lawyer in order to access services of the clinic.

Legal advice & Information appointments are not subject to the same prioritization, this is only for deciding which cases to represent in full. This may change with time.

Emerging Issues

- 1) Our **Border** is closed so there are difficulties for those trying to reach Canada.
 - Can make a claim at the airport but now it's much harder to get here.

US border also closed: refugees are still subject to Safe 3rd country agreement.

Before COVID refugees did cross irregularly - but the new OIC with the US means if refugees cross irregularly and are detected they can be directed back even if they say they want to make a claim, and we don't know what happens to them when they are sent back.

Govt. insists there is a diplomatic note filed so they would not be detained, but there is evidence that some have been detained in the US after being sent back, and subject to removal proceedings.

Concern that this might become a permanent closure for irregular crossers – important area for advocacy

- 2) **US Asylum policy** proposals for changes to asylum policy are shocking not fulfilling international law and nowhere near what someone would receive in Canada.
 - No decision yet on the constitutional challenge that was heard in November 2019 in Federal Court challenging the validity of the Safe 3rd Country Agreement.
- 3) **COVID and refugee processing:** Negar will cover IRB procedures but clients are very concerned because of delays in hearings and all procedures which will delay PR processing and family reunification.
 - Important to examine how new IRB processes will be fair and efficient.
 - There are apparently discussions about special govt. programs to deal with backlog for example a government briefing note was made public that recommended essential health workers refugee claimants may be part of a special program for accessing permanent residence. This is all just rumours now and nothing official.
- 4) **CBSA oversight** there is no independent accountability mechanism this issue is very important for clients in Jan 2020 there was a proposal in govt to create a process for complaints but because of

COVID it's delayed.

Really important to advocate over the fall/winter session.

QUESTIONS & ANSWERS

Are legal services free?

Response: Yes, if financially eligible for services.

Are they just for clients in Vancouver?

Response: No – they are a provincial legal clinic though how to manage will be an ongoing discussion to address gaps and provide most useful help.

Q: Are any areas of law off-limits for clinic? E.g.

- H&C cases?
- cases of people who are in limbo because of inadmissibility for security reasons?

Response: Generally given our mandate to serve low income clients, we would not be working on economic immigration cases or residency appeals. We also would not generally do full representation for a processing case that didn't require legal submissions. At this point, we are not otherwise restricting particular issues but need to look at each case and decide whether it fits our priorities and capacity at the time – specifically: is there a complex legal issue, is there a client care sensitivity issue, or is there urgent, immediate action required.

Q: Can clinic mentor refugee lawyers?

Response: yes, we would like to do this – it's very important and there's no other place in Vancouver that does this.

We lose many senior lawyers to the board or other opportunities, so we have to support the learning of new lawyers or how to partner on cases etc.

Q: If someone crosses the border, does that mean he/she will be deported to the US?

Response: Since approximately 2002 the Safe 3rd country Agreement has covered official port of entry land crossings – asylum seekers who cross at a land border are turned back unless they fit an exception in the agreement – most common exception is existence of a family member in Canada.

This agreement is still operating during the pandemic – the new temporary border closures do not affect how claims from those arriving from the US are treated at official ports of entry. But for irregular crossings (like Roxham Road) who wish to avoid Safe 3rd Agreement, persons who are intercepted while crossing are directed back to the US. Canada claims this is a temporary measure during the pandemic – but we have no idea if this practice might be continued.

Q: If someone is detained can they apply for legal aid assistance?

Response: Legal Aid funds are available for representation by duty counsel for detention reviews, usually the 48-hour review, but during COVID-19 duty counsel was are making all detained cases applicable. More generally legal aid is available for hearings, PRAA etc. regardless of whether you are detained.

Update from Immigration Refugee Board on Resumption of Services

Presenter: Negar Azmudeh, Special Advisor to Senior Chairperson

- Practice Notice of Resumption of in person hearings was posted on June 23
- June 15 there was a **partial opening of office** with small staff in registry office because of distancing necessities.
 - Only a 30% occupancy rate allowed including those from outside too.
 - So IRB is open for business, but in a very restricted manner
- Will likely use multiple hearing rooms to allow for one hearing because of physical distancing
 Only have one room that's big enough for multiple parties, otherwise must use multiple rooms
 or member can attend from home/office/or another hearing room.
 So, practice notice is very aware of the problems this will bring, and so some rules will be
 relaxed e.g. waived need for original documents unless really necessary.
- Good news receiving documents by email but not sending out. Still have 2-way communication via e-post and fax as well.
- Piloting a remote hearing project starting next week different to the resumption of hearing system.
 - Remote hearing pilot project is different entirely remote everyone will be online.
- **Videoconferencing** in western region about 50% of hearings were processed by videoconferencing pre-COVID because of remoteness. We are aware of the obstacles with this and hope to gain feedback.

In-person hearings will always be important for vulnerable clients to avoid re-traumatizing them However, right now we have to deal with COVID restrictions while allowing hearings to take place with less delay and in a full and fair way.

Questions & Answers

Q: Is the IRB going to keep the scheduled in-person hearing dates for those claimants that already have dates after July 20?

Response: Unless you hear from us about a postponement yes, the dates will go ahead as scheduled. When you attend you will be directed to a different hearing room or use of plexi-glass. So it won't be exactly as the client expected.

There are restrictions also of time – need one hour for clearing between hearings that might mean some delays, but we don't know yet.

Q: The postponed cases, how will they be scheduled for hearing again? do they have priority? **Response:** We are looking at a number of factors: those that are hearing-ready, those postponed because of COVID. But there are other factors like vulnerabilities – psychological needs.

If you have a case that you think merits priority please contact us and flag it.

Q: Is the RPD considering use of Plexiglas in the hearing rooms?

Response: yes, but it's still not enough – the rooms are too small for the number of people present. We are doing everything we can to maximize our resources for the greatest number of hearings. But clients and agencies should expect some videoconferencing in each hearing probably.

• Q: What is the criteria to choose which hearings are held via video-conference?

Response: Definitions first:

Remote hearing – is all by video-conferencing. Everyone is remote.

The **in-person hearing** may have some video-conferencing component – in various locations.

Q: How are you selecting hearings for the pilot?

Response: I am leading the pilot project so I can provide information.

It is a completely **consensual project** as everyone is located from their home or office. Counsel may be with claimant or not.

Very small pilot project – max 5-10 cases per week to see how it goes.

The proceedings take place secure IRB/government video-conferencing equipment with secure recording capabilities, but claimants and counsel may not have equipment that is of the same level of security. Because of the potential for security breaches with non-IRB equipment the claimant and their representative have to accept that risk as theirs.

That is why we say it is fully consensual as the representative and claimant need to be aware of this risk before they take part in the remote project – and the representative must explain this to their client, who must provide consent.

Therefore the project is only accepting claimants who are represented.

The clients also have to provide other sureties, e.g.

- They will be located in a private place, it could be with their representative but cannot be in a room with other people.
- Must have their own device smart phone, computer, tablet that connects to high speed internet
- Must have access to all the same documents if they are not co-located with their counsel.

We have explained all this in an introductory letter – we have contacted a number of counsel who are on e-post and have a number of cases, but this is still very small-scale.

We are providing access to full justice as the clients can still opt to have their hearing in a more traditional manner at the IRB.
