Results of MAP Executive Planning Meeting Oct 1st

MAP Executive met October 1st in person, outside and distanced at Options CS kindly hosted by Jenny Lam.

Following the Strategic Planning that took place in 2018 it was appropriate to update MAP's plans for 2021 according to our goals and feedback from membership.

Here are the decisions that were taken and are now referred to MAP membership for approval:

• To provide more public education:

- a) 4-part lecture series in January, April, September, November
- b) expanded World Refugee Day event hopefully online AND in person
- c) 2 'Starting over' events in Surrey + another municipality possibly Burnaby.
- To support this MAP will **re-establish the Information Working Group** and calls upon agencies and individuals to volunteer and make their voice heard in this important endeavour. If you would like to find out more please email or call Jenny at MAP.
- MAP will make contact with other refugee claimant networks throughout Canada to strengthen collaboration, advocacy and support to claimants.
- A MAP sustainability plan for future funding will be further investigated and presented to MAP membership at a later date.
- The **MAP Terms of Reference** (along with the HWG TOR) have been updated and will be presented for MAP member approval at the November meeting.

KEY Message: lack of education or skills, language, transport problems can all be barriers to successful job acquisition – Options helps claimants prepare to be job ready. In terms of 'Canadian Experience'

they help refugees identify what they have done in the past that can relate to jobs here – even finding suitability for those with no paid experience.

Salih Arif: MOSAIC

Settlement & Work Access Worker / Refugee Settlement & Integration Program

Parisa Roofigari: MOSAIC Settlement Outreach Worker Please see attached slideshow

KEY message: MOSAIC encourages refugees to volunteer to gain that Canadian experience. At the agency there are many staff and volunteers who are working for MOSAIC who eventually came through their Employment Program.

Questions and Answers:

Q: How do you help clients overcome the Canadian experience question?

Parissa – volunteering here at MOSAIC in events etc.

Masa - must work at both ends with both refugee job seekers and employers -

- empower and represent and advocate for refugees
- talk to their diversity & inclusion departments advocate for refugees to be a specific part of their mandate of inclusion. And educate about refugee talent.

Shelley – educate the wider community about refugees

Q: What can we do to advocate?

Shelley – raising awareness of skill levels of RC's – peeling off barriers that block clients and employers meeting each other. Networking and sharing stories. Talk to your own family.

Salih: 'Table Topics' is a MOSAIC program that helps clients share their experiences and skills to help each other.

To provide claimants opportunities in our organizations – as volunteers, especially, during COVID.

Richard: At WRD inasmuch hosted a local event with the Abbotsford Chamber of Commerce called 'Why hire a refugee?' – encouraging employers to take a minute to really look through resumes. Sharing on LinkedIn.

Q: What is one thing as a service provider you could put in place to help RC's gain employment?

Parisa – partnerships with employers like Lush etc. – established connections get the job opportunities Provide excellent training: our statistics show that

783 RC's accessed employment services – 425 of them secured a job!

Masa – make the best out of what is available – don't duplicate – connect with other agencies who offer other services, but Jumpstart will do the advocacy work.

Salih – building relations in the community and with employers, making appropriate referrals.

Shelley – training and employer connections – and specialized services.

Presentation: CBSA Quarterly Update to MAP PART A) Update from the Immigration Holding Centre

Katherine Zhang: Acting Manager, Detention Operations and

Alex Currie: Acting Manager of Detentions

(Sharon Sandhu not able to attend. Katherine is filling in as she has actually left the IHC position and is handing over MAP Contact person designation to Alex Currie who started on Monday.)

Last update was in May and since then the facility is opening up slowly to visitors in a controlled way. Visitors must be pre-approved and follow all COVID protocols.

Legal counsel, friends and family may now visit if pre-arranged.

Medical staff there 24/7 – new arrivals isolate for 14 days and health monitored daily for COVID to protect rest of detainees and staff.

Alternative to Detention Program: Jolene GRANT – Community Liaison Officer for Pacific Region

Jolene introduced **Joanne Jesbir** – acting community liaison officer in training currently with Jolene.

Voice Reporting system – since last update this system was largely on hold because of COVID But now Pacific region has opened up for enrollments for voice recording – 1400 files to review and 200 left to do to. The vast majority will be able to convert to voice reporting.

This will be a big help for those in Chilliwack or Fraser Valley – will have full 24 hours to report.

And Ottawa will send reminders too.

So unlikely to see failure to report – 2 reminders then more serious follow up.

Pacific Region is leading the way of enrollment in voice recording during COVID. Some other parts of Canada are yet to open up to voice reporting.

Enrollments can take place at the downtown office or at IHC.

Community Case Management – have reviewed the vast majority of the long term cases – have referred majority to Belkin House for high risk clients or Kensington House run by John Howard Society. there out of detention.

Programming in the community has opened up for them.

Kensington House – just opened up in spring – 2 placed there – home based on Elgin St in Vancouver. Individual has more freedom. Learns to provide for themselves in terms of life skills – works with John Howard Society to get work permits and any necessary ID.

One about to graduate from Kensington House – very positive case because had mental health challenges. Lots of recent successes now things are opening up.

Questions & Answers

Q: Is Chatr allowed for voice reporting?

A: No to Chatr or Freedom: main providers only, like Telus, FIDO

Q: What about Koodo

A: Yes, with a contract.

Richard updated MAP on our conversation with CBSA about the **NGO presence at IHC** they have requested. Covid delayed the start up but now they are interested in having:

- Someone who at the start would be attending half a day or one day per week.
- Preferably would like one contact who can refer out to appropriate agencies for security issues
- Needs to be an agency/person with thorough knowledge for detainees.
- There is a room with socially distanced protocols for Covid in place

Q: how many RC's are in detention center now, and are some ready for release?

A: 13 detainees in at present – 2 or 3 in process of moving out. Not many here.

Comment from Sabrina (AMSSA) – In terms of NGO presence at the IHC funding for NGO's will need to be discussed.

Richard: Yes, we definitely must discuss, but it is heartening to get the conversation started.

Q: – are there videoconferencing facilities to allow detainees to do a ready tour remotely on Microsoft Teams?

A: We would need to look into that with the IRB to see if it was possible. The equipment is available.

Q: - Are there any ways CBSA reach out to NGO's when a detainee is ready to leave? How do you help those who are ready to leave with their housing?

Jolene: If person is released under terms and conditions then they are released according to ATD program:

- high risk clients go to Belkin House facilities
- medium risk clients go to Kensington House if they are willing

More likely your question is about Low Risk:

 low risk clients go via John Howard Society who look for transition housing through their contacts like an SRO, shelter or community residencies like Kinbrace

If you have a space available you can let CBSA know and we will ask John Howard to check it out as it must be suitable so that the client can abide by terms and requirements

Q: Can you please provide more information regarding the "risk" that you are mentioning?

Normally those at Belkin are high risk with a strong criminal history with violence – may be a danger to themselves or public. Often have addiction issues and/or mental health issues.

Belkin House can assure that the clients get a full program and supervision so they get to all their appointments especially in terms of medications and addiction, and mental health programs. As they get better and address their problems, they gain more freedom so that they can get up to 8 hours/day of freedom within Belkin House.

Also have to be sure they will comply with immigration requirements of reporting.

Medium risk – those who just need an extra bit of help to function – minor criminality, some addiction issues but can be brought back on track – medium risk is 90 day stay (at Kensington House) usually.

Low risk – just need someone to help them with their lives – permits, housing. Need to develop a relationship with a caseworker.

Q: What is CBSA's expectations of an NGO on site?

Richard: CBSA said one day or half day with an NGO agency on site who can address all issues for detainees or refer them.

We don't have a lot of information right now – but please let Jenny Moss know if you have the slightest interest or questions.

Housing Update

Update from CHARMS Project - Marzieh Nezakat (MOSAIC)

(BC Refugee Claimant Housing & Referral Management System)

Steps taken so far:

- Advisory Committee has held 5 monthly meetings
- Marzieh was hired as project coordinator
- Scoping exercise: of the housing inventories, related referral and data systems in Canada and internationally (this project is province-wide)
- New assistant: Jacqueline Sarvini
- Tech consultant hired: Hussein Idris who will create the Requirements Document for the system
- Participatory approach so everyone's expertise and experience needed **survey created**. It will be sent out very soon. 2 reasons for the survey:
 - a) current practices regarding refugee claimant housing
 - b) system requirements to better serve refugee claimants in housing. Encourage everyone to respond to the survey it will be sent out to all MAP members.
- After that there will be 1:1 interviews please contact us if you want to participate in a 1:1 interview via new email: BCCHARMS@mosaicbc.org. Interviews will start first week of November.

Q: Are you looking for one person per agency for the interviews and survey?

A: We have created a very comprehensive list of stakeholders in BC: agencies, emergency housing providers, govt.

Interviews can be joint interviews.

If there are multiple emails Marzieh can send out emails to more than one employee.
