The new **Office of Homelessness Coordination** is working across government and with community partners to deliver a co-ordinated response to homelessness. The office's approach is based on four pillars:

- Prevention, to make homelessness a rare occurrence;
- An immediate response, to make the experience brief;
- Stability so that homelessness is a one-time occurrence; and
- Working together to co-ordinate actions on homelessness.

With BC Housing and other partners, the office is helping to co-ordinate the second provincewide homeless count, to be conducted in spring 2020.

Q & A

Q: Why does the child tax credit cease after three months?

A: There is a three-month limit on the benefit. The system only allows for three months' benefit at a time – applicant needs to ask for an override to continue receiving.

Q: MSP - What is the client's responsibility (after the client/service provides necessary information e.g.: work permits and SIN number to start MSP healthcare? What more can be done to make sure that MSP is provided?

A: MSDPR can only provide 42 days – once client is in the MSDPR system he/she needs to fulfill ID requirements through ICBC, including photo ID.

Note: Claimants facing any problem with ICBC regarding MSP papers, their coverage and photo ID that results in them being turned away, please report to Claudia so she can bring to John's attention.

Q: Families who are not eligible for a positive decision by the Protection Division, are they eligible to get income assistance from ministry?

A: Failed refugee claimants going through an appeal process or who have an enforceable deportation order or are going through the risk assessment, can be eligible for assistance.

NOTE: If they are not failed claimants (new PRAA system clients) they would not be eligible. But the ministry will have to look at each case because sometimes clients misinterpret their documents.

Q: In the case of families who have been here for more than 18 months and are not eligible to get Child Tax benefit because their refugee status has not been decided; Are they eligible to get the family bonus?

A: Yes, the ministry can extend it beyond the 12-18 months but still the ministry has to check to prove that the family have attempted to apply and what's caused the delay.

Q: What is the right amount of exemption/ deduction for working families of two, is it \$400 or \$600?

A: The ministry's table of deduction is available on the website and can be checked for individual cases.

Q: (PWD) Disability Benefit – what about mental disabilities? These clients are not getting approved.

A: That's on a case by case basis. What sometimes happens is that the doctor isn't checking moderate or severe disability in the application. The ministry needs to know in detail what the limitations are, so it's best to describe the worst day of pain and struggle. Mental same as physical conditions.

Q: Where can I refer Refugee Claimants to fill section two and three of the PWD application?

A: You can send them to Zaytuna Services Society in Surrey if they need help in section one and speak Arabic.

Q: Is there any likelihood of an increase in the shelter portion?

A: In a short answer, yes. They are looking at new rates, the problem is that as soon as the rates are raised landlords put up the rent. So, the ministry is trying to figure out a way to coordinate with other ministries to create policy to avoid this. However, it still doesn't mean it would be an increase for everyone.

Saleem:

We will bring MAP members' comments regarding issues pertaining to claimants to CCR, BC always participates fully.

- One of the sessions that Saleem (MOSAIC) will run is an open discussion with CBSA. So please describe any issues or questions that Saleem can bring forward.
- Another important discussion will be with the IRB.
- There will also be an Executive election: some of the members are running again and some are new. If you are a member and attending please look at the nominations and try to include voices of BC. If your organization is a member, or you are an individual member and you haven't renewed your membership with CCR, make sure to do so before the consultation starts so you can vote.

Mariana:

The Inland Working Group she co-chairs represents claimant issues.

There will be a special session on border issues and the new PRAA process (with Fran):

Fran:

The panel organized at CCR will include Martin Mendell, a senior manager at IRCC and others. The panel will describe the new PRAA hearings, as we haven't seen any of these hearings yet. In addition, Stephanie Valois (lawyer), Alexandra, Jennie Jeans, FCJ Toronto, will be on the panel. These sessions are very useful as government officials are responding to questions and concerns that CCR members have.

Jenny:

There will also be a local opportunity to bring claimant issues forward on Monday Nov 25th, at a meeting with Azadeh Tamjeedi, UNHCR rep. Register to attend with Jenny.

Q&A:

1. For Saleem – the growing issue of secession of status among refugees. Clients currently in the process of applying for their citizenship are receiving letters from CBSA of possible revocation of PR. These letters state that they might get their PR or refugee status revoked. It's an injustice. Canada is the only country that gives refugees PR status, but at the same time, they want to take it away from them. It's not fair and it doesn't make sense. Please request to cease this practice.

There was further clarification of the problem and an assurance that this issue will be taken to CCR.

 MSDPR staff would like to see a sample of the new documents given to border crossers who will enter the new PRAA interview process – in order to compare.
 MSDPR will take this up with policy managers at the ministry.

SALEEM: A meeting took place in September with IRCC and their director general. When the issue of documentation was the Director General said that their understanding was that the provincial governments would use that document (pink form) as an accepted document for the purpose of applying for income assistance. And when IRCC was asked if they had shared that information with their provincial counterparts, the Director General said that was his understanding.

There is a lack of information and sometimes inconsistency in documentation resulting in different results re: work permits, welfare etc.

IRCC had promised to have things synchronized but it has been very challenging. CCR will bring this up with the appropriate government contacts.

For now, please make sure that applicants understand so as to not increase numbers of homeless people and vulnerability for applicants.

MARIANA: Suggested there be some kind of clarification on top of the Pink paper that says "this form makes you eligible to apply for social assistance and receive medical services". CCR will also be focusing on the Americas and Migration Flow.

Update on the MJTT project: Refugee Claimant Housing Referral and Management System

Richard Belcham and Saleem Spindari

To recap MAP has been offered the opportunity through a MJTT-funded project to design a central intake and referral system for refugee claimant housing. At the last meeting we agreed on the criteria for application of a lead agency and on the Advisory Committee roles. MOSAIC won MAP's endorsement to be lead agency.

Since the last meeting, the proposal was submitted by MOSAIC to MJTT. There are some amendments and clarifications required; this will be done today, and the proposal resubmitted once it has Executive approval.

The budget had been submitted for the entire amount (\$1.2 m) without separating it into different fiscal years (2020 - 2022). This will also be adjusted and once approved by MAP executive it too will be submitted to the ministry.

As soon as approval is received from MJTT, then the bid will be posted on BC Bid for a couple of weeks then it becomes final if no concerns are raised after it's posted. MAP will also invite nominations for the Advisory Committee at that point.

Everyone will be updated through MAP bulletins so you know where the process is and how it's coming along.

Hearing from you! Sector dialogue based on the question:

What specific issue pertaining to refugee claimants do you think is important? The following topics were suggested, Housing was taken for granted as #1:

- Refugee claimant housing at all stages
- Funding for mental health.
- Completing PWD form (Sections 2&3) for non-English speakers in a non-traumatic way
- Medical practitioners education about refugee claimants.
- SWIS Workers to formally include refugee claimants.
- Safe 3rd Country legislation
- Dental health.
- Trauma-informed medical services
- Transit costs.
- Regional issues for RC's in BC
- 'Bills for babies' how to streamline MSP services application for newborns
- Financial literacy; where they go prior to opening up an account and learning about credit cards and how to use them wisely.

- Being careful of Immigration Consultants: exploitation of vulnerable minorities.
- Better channel of communication with Canadian Border Services Agency and ministries (e.g. when it comes to deportation orders). More updates to MAP.
- MAP BC and FV MAP to work closer together.
- Family shelters.

MAP Co-chairs will discuss these suggestions when planning 2020's goals.
