Jordan responded to a question from the last meeting regarding **current timelines for claims** to be heard by the IRB:

The IRB uses a number of scheduling priorities when setting hearing appointments so it's not possible to give an 'average wait time'.

Priorities include those detained, vulnerable, unaccompanied minors – these cases are always reviewed first

In addition there is a Task force for less complex and gender related claims.

In reality waiting is part of the capacity issue the IRB is continually facing.

• Information WG Report: IN FOCUS events in November

Jenny provided information about the upcoming In Focus event at Renfrew Library (VPL) in east Vancouver on Nov 28: Seeking Asylum – Law and the Journey of Refugee Claimants. This is the second in a series of dynamic presentations from a refugee claimant, a lawyer and a settlement worker.

PRESENTATION: Options to PR

Presented by: Prabhpreet Kaur Sangha, Immigration Lawyer

Speaker introduction: Prabhpreet Kaur Sangha was raised in Surrey and pursued an undergraduate degree at Simon Fraser University. She earned her Juris Doctorate and Certificate in Dispute Resolution from Willamette University located in Salem, Oregon. She was called to the British Columbia Bar in December 2019. She practices solely immigration law with focus on victims of family violence and abuse, refugee claimants, and enjoys appealing refusals to Federal Court. She was a Board of Director with SABABC and is a current member of SALCBC. She has appeared on local television and radio to discuss legal issues. Prabhpreet's parents immigrated to Canada and as a first generation Canadian she understands the hardships that immigrants encounter on a personal, financial, and emotional level. She is passionate in uniting individuals with their families and representing individuals in vulnerable situations.

QUESTIONS & COMMENTS

- Kinbrace: a suggestion that MAP should start a conversation re: misinformation and misnomers about Internal Flight Alternative. Also there are situations where a refugee claim is made after a visa has expired for good reason: e.g. sudden change in security in home country.
- Clarification requested re: what kind of waiver might be signed at the detention centre? Response: A person's right to H&C/TRP application process
- Loren (Kinbrace): Top assistance MAP members can provide to support the refugee claimant:
 1) settlement agency should consider sitting with the client in their interview with lawyer to help with letters/forms etc
 - 2) write letters of support this really helps.
- VAST: to build on Kinbrace's first statement Canada has a responsibility under international conventions on torture and refugee protection: there is a grave likelihood of torture on return to certain countries.
- Extend the time needed to complete forms for the Basis of Claim application (15 days currently) (see Jordan's notes later)

Gather insights from the Membership in relation to the SOAR analysis that can inform the Advisory Committee to assist with decision making/prioritization

Present the results of the survey to ensure all voices are heard.

Outcome: Understand the perspective of the membership as a whole and what they see as the strengths, opportunities and aspirations for MAP BC. This foundational information will inform the Results and Goal discussion in the pm

Housing Working Group Report

Note: The HWG decided that henceforth the report to MAP membership at the general meeting will widen to include other critical issues being discussed and worked on. So, the report is re-named although the BC CHARMS section continues to be a top priority.

Doug Peet (HWG Co-chair)

Marzieh is away at the CCR consultation

Doug encouraged other MAP members interested or involved in refugee claimant housing to consider joining the HWG. Please contact Jenny or one of the co-chairs for more information.

- At this point HWG is embarking on a large research project about housing for claimants on arrival. We encourage any potential researchers to join.
 - The question we are asking is: What housing do we need for claimants when they first arrive We will research who across Canada is funding/housing refugee claimants when they first arrive.
- Doug attended the recent **Housing Central Conference hosted by BC Non-Profit Housing Association**. There were great mentions of BC CHARMS and Meanwhile Spaces projects.
 - But at the same time when Doug asked about the \$4.8 m that sits with provincial govt for refugee claimant housing the answer provided was nebulous appears that the issue is that housing should not be provided for refugee claimants when there are Canadian citizens suffering homelessness. Doug underlined the point that access to housing should not be based on time in Canada but on vulnerability.

A meeting on the subject with Dale McMann of BC Housing will take place in the new year.

- **BC Housing RFP (due Dec 15)** out right now for housing subsidies provides tops ups to rental in the market one population eligible is newcomers including refugee claimants. Provides for 10 or more housing units that might continue in perpetuity (good for large families)
- **National Occupancy Standards** not included in report card type standards, it is an ADVISORY only as recognized as inappropriate.
- Housing Working Group will take on this research based on a shared platform looking at what is happening in other provinces.

The data will then help us advocate here in BC for similar facilities.

e.g., there are hardly any family shelters in Vancouver as compared with Ontario we also need to advocate for dedicated space for refugee claimants

Comments: we need to know the numbers of homeless people (someone has info??)

Response: Marzieh & Nikita are in Toronto currently and will investigate refugee shelters and learn from them

Frank (VAST) – we know that regular shelters are more harmful to refugee claimants **Julia (bc221)** – more information is available on shelters being inappropriate, and also that refugees are often refused entrance by shelters. E.g., Fathers with children have nowhere to go

Issues, concerns and updates raised by agencies

Note: This section is now for raising issues of concern for agency discussion and mutual help

1) Iris (Options) sent in an issue to discuss:

Options is seeing increased demand to complete Refugee claim forms (BOC).

Claimants are facing challenges in securing legal representation. Legal Aid is taking longer to assign lawyers, and lawyers are taking time to complete the forms. We have heard that lawyers are having issues finding interpreters.

Clients who have made the refugee claim at the border receive an appointment to return to CBSA with the completed forms mentioned above. If the clients still need to secure legal representation, they struggle to complete the forms by the time they need to return to CBSA.

Ana: added that it takes more than a month to get a Legal Aid lawyer – and sometimes they need to be reassigned if not a good fit. This month Patricia has had to help claimants with their forms.

This is problematic as it includes the claimant's narrative – and this needs to be done by a lawyer to get it right

But without this step claimants cannot apply for financial assistance, housing or a bank account.

Response:

Prabh (lawyer): might be a good idea to ask for more time from CBSA

Katya (SOS) asked how much time on average a lawyer is dedicating to the forms for BOC? *Response:*

Prabh: we usually have to do it again from scratch – so this takes a few hours.

Sometimes lawyers might do an amended BOC later on

2) Issue: Cagri (Rainbow Refugee) – helping a minor claimant: has anyone had any experience with an unaccompanied child going through the MCFD agreement?

Please email inland@rainbowrefugee.ca if you have any ideas.

Cagri also passed along that some of their clients have reported homophobic or transphobic environments or language at some agencies – please be aware.

3) Issue: Imtiaz (Fraser Health) – COVID numbers are up!
Please be aware that newcomers need information about vaccinations.
Don't shake hands, wash your hands frequently and wear a mask indoors.

4) Issue: Jordan (IRB) – on the theme of the 15-day BOC time limit – during the pandemic there was a 30-day extension (45 days extension for ports of entry) for the BOC.

Jordan will reach out to CBSA to clarify that they are following this guideline.

Please note: If within the timeframe there is no response from the claimant then the case is considered abandoned – but you can always ask for more time if it is needed – **PLEASE COMMUNICATE with the board.**

Prabh (lawyer) agreed – it is always very important to ask for more time or whatever you need.

Ali Mustafa (MFB) – has been waiting for security screening (15 - 20 months delay) for RC and PR applications.

Response: Prabh – you need a lawyer to write a letter, or get the MP involved.
